TWO DIRECTORS AND TWO ALTERNATES ARE SELECTED BY THE MEMBERS OF THE ALASKA BAR ASSOCIATION IN THE FIRST JUDICIAL DISTRICT. ONE DIRECTOR AND ONE ALTERNATE ARE SELECTED BY THE MEMBERS OF THE ALASKA BAR ASSOCIATION IN THE SECOND JUDICIAL DISTRICT.

ONE DIRECTOR AND ONE ALTERNATE FOR EACH OF THE THREE SEATS ARE SELECTED BY THE MEMBERS OF THE ALASKA BAR ASSOCIATION IN THE THIRD JUDICIAL DISTRICT, IN ACCORDANCE WITH THE FOLLOWING GUIDELINES IF POSSIBLE: SEATS A AND B. BOTH THE DIRECTORS AND THE ALTERNATES SHALL BE SELECTED FROM THE GENERAL DISTRICT MEMBERSHIP. SEAT C. THE DIRECTOR AND THE ALTERNATE SHALL BE SELECTED BY THE GENERAL DISTRICT MEMBERSHIP FROM THE FOLLOWING GROUPS OF THE ALASKA BAR ASSOCIATION MEMBERS: 1. ATTORNEYS WHO RESIDE IN THE KENAI PENINSULA JUDICIAL SERVICE AREA; AND 2. ATTORNEYS WHO RESIDE IN THE KODIAK ALEUTIAN JUDICIAL SERVICE AREA.

TWO DIRECTORS AND TWO ALTERNATES ARE SELECTED BY THE MEMBERS OF THE ALASKA BAR ASSOCIATION IN THE FOURTH JUDICIAL DISTRICT. THE DISTRICT SELECTIONS ARE SUBJECT TO CONFIRMATION BY THE BOARD OF GOVERNORS OF THE ALASKA BAR ASSOCIATION. THESE APPOINTMENTS SHALL BE MADE SO AS TO ENSURE THAT THE ATTORNEY BOARD MEMBERS INCLUDE WOMEN AND MINORITIES AND REASONABLY REFLECT THE POPULATION OF THE AREA SERVED.
