Located in Anchorage, this position is responsible for mentoring, providing feedback, serving as course instructor as needed, and arranging for court observation opportunities for pro bono CJWs. The Pro Bono Training Attorney also identifies, plans, and implements continuing education and professional development opportunities for pro bono volunteers in conjunction with other CJWRC staff, co-counsels on cases as required or requested, and travels as needed to support pro bono CJWs in court observation, co-counseling, and related duties.
